Ranch Park Lodge will not place any charges (other than pre-authorization) on the card for the security deposit unless there is damage, a cleaning charge, or a penalty as described in the Terms & Conditions. When providing credit cards for a security deposit, the card must have an expiry date effective at least 45 days beyond the end of the rental period.
